

BUILDING SUMMARY

In February 2025, the Building Division issued 44 permits with a total job value of approximately \$3.2 million, indicating substantial activity in residential development and property improvements. HVAC projects led with 17 permits valued at \$239,789.31, representing 38.6% of the permit count and showing a focus on heating and cooling upgrades. Five single-family dwelling permits, primarily new homes with solar installations, contributed \$2,483,933.11, or 77.6% of the total value, reflecting significant residential growth and sustainable construction. Other activities included three water heater replacements at \$10,874.75, three reroofs at \$93,754.95, and two residential PV solar projects at \$124,531.69, with additional enhancements totaling \$237,535.33. The division supported this workload with 5 plan reviews, 55 inspections (14 virtual and 41 in-person), and 8 Certificates of Lateral Compliance, demonstrating effective permit processing and oversight.


