

CITY COUNCIL NOTICE OF PUBLIC HEARING

Notice is hereby given that the City Council for Placerville will conduct a public hearing on <u>Tuesday</u>, <u>August 27, 2024 at 5:00 P.M. at Town Hall, 549 Main Street</u>, <u>Placerville</u>, <u>CA</u>, to consider the recommendation of the Planning Commission to approve the following requests:

Zone Change (ZC) 24-02: Amend Title 10 (Zoning), Chapter 5 (Zoning Regulations), Section 15 (Commercial Zone) to clarify Subsection (B), Permitted Uses and Subsection (C), Conditional Uses, with regards to a Place of Entertainment and new and used retail sales.

Zone Change (ZC) 24-03: Amend Title 10 (Zoning) of the Placerville City Code to address required 2021-2029 Housing Element Implementation Program B-7 (Family Daycare Homes) to comply with California Health and Safety Code §1597.45 and Senate Bill (SB) 234.

Zone Change (ZC) 24-04: Amend Title 10 (Zoning) of the Placerville City Code to address required 2021-2029 Housing Element Implementation Programs B-2 (Supportive Housing Zoning Amendments) and B-8 (Residential Care Facilities) to comply with Assembly Bill (AB) 2162.

<u>Environmental Review</u>: Per the California Environmental Quality Act (CEQA), the City has determined the projects to be exempt from environmental review pursuant to California Code of Regulations, Title 14, Chapter 3, §15060(c)(2) and §15060(c)(3).

Any person interested in these matters is invited to attend and present testimony either for or against the proposed application. If you challenge the action taken on these matters in court, the challenge may be limited to raising only those issues raised at the public hearing described in this notice, or in written correspondence to the Development Services Department at, or prior to, the public hearing.
